### **FIXED TERM AGREEMENT**

This **AGREEMENT** made and executed on this 12<sup>th</sup> day of January 2024 by and between **Crystal Crop Protection Limited**, a corporation organized under the laws of India having its corporate office located at B - 95, Wazirpur Industrial Area, New Delhi – 110052 (hereinafter called "**Company**" which expression unless repugnant to the context thereof shall mean and include its successors, representatives and permitted assigns) of the one part;

And

**Brajesh Singh Bhadoriya, Ward No. 1 Lahar Distt Bhind, Madhya Pradesh, Pincode:477005**, (here in after referred to as "**Management Trainee**" which expression shall unless repugnant to the context thereof shall mean and include its successors and permitted assigns) of the other part.

**Company** and **Management Trainee** shall be hereinafter collectively referred to as "**Parties**" and individually as "**Party**" depending on the reference.

### **WHEREAS**

- A) The Company represents that it is the business of manufacturing of Agrochemicals and Seeds has significant knowledge, skill and experience in manufacturing, formulate, refine, process, selling and trading crop protection chemicals viz. Pesticides, insecticides, herbicides, fungicides, Seeds and farm equipment.
- B) **Management Trainee** has represented to the Company that he/she has got the competence, experience, knowledge and required expertise and has agreed to engage with the Company.

**NOW, THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

### **1. DEFINITIONS:**

In this Agreement, the following definitions shall apply:

"**Agreement**" shall refer to this Agreement or any modification / amendment thereof as may be mutually agreed upon between the Parties.

“**Confidential Information**”, with respect to Parties, shall mean and include all proprietary, commercial, financial or strategic information relating to the Parties (including without limitation any Content, Data, non-public personal information, know-how, market research, marketing techniques and plans, business strategies, services methodologies, trade secrets, software programs, any other information related to the subject matter, terms and conditions of this Agreement, which is marked or notified to the receiving Party as being confidential), together with any other information which in the normal course of business would be considered to be of a confidential nature, whether or not the same is marked or notified as being confidential.

“**Effective Date**” shall mean and refer to the commencement of Services i.e., 01st February 2024.

“**Compensation/ Stipend**” shall have the meaning ascribed to the term in Clause 4 of this Agreement.

**The scope of the Management Trainee is given below:**

The incumbent will be responsible for business activities of **Crystal Crop Protection Limited** for the Seed Business at Ratoul, Uttar Pradesh as assigned by the management.

**2. APPOINTMENT:**

- a. Company hereby appoints the Management Trainee as to provide the Services on fixed term basis and the management trainee hereby accepts the said appointment and agrees to provide the Services in accordance with the terms and conditions set out herein.
- b. The Management Trainee shall maintain the highest standards of business ethics as generally accepted in the industry.
- c. As, Management Trainee shall report to **Mr. Pushpendra Kumar (Regional Manager)** and administratively reporting to **Mr. Amit Rana**.
- d. Management Trainee shall be based out at **Muradnagar** and shall be required to travel to the other locations of the company as may be decided mutually by the Parties.
- e. As management trainee, you will be provided with time-to-time training & the same will be reviewed by your reporting manager.
- f. Management trainees are eligible to **25 days** consolidated leaves, the same will be taken on account of casual / sick / planned leaves. There is no provision for leave encashment during or the end of the fixed term contract period.

- g. Management Trainee shall upkeep and maintain all Confidential information, company property viz. laptop/desktop computer, correspondence material, documents, electronic files, films, inputs, exhibits etc. provided to the management trainee by the company during the Term for providing the Services and shall produce the same as and when required, on request. The Management trainee shall return the same to the company without any reservations or delay, as and when instructed to do so on his leaving or early termination of this Agreement.
- h. Management Trainee shall follow and will be bound by the rules and regulations of the Company and maintain complete discipline in the organization. The Management Trainee shall abide by all the administrative rules and regulations as applicable to the Company. Failure to do so will render management trainee liable for early termination of the training period.
- i. Management Trainee shall honestly, diligently, and efficiently discharge trainee duties delegated by the Reporting Manager or relevant representatives of the Company to perform the Services, under this fixed term agreement.

### 3. TERM

The appointment shall be for a fixed term of 1 (One)Year, valid from **01<sup>st</sup> Feb 2024 ("Term") till 31<sup>st</sup> Jan 2025**. The Agreement shall automatically come to an end after the expiry of the term. However, Company reserve right to terminate agreement before expiry period without assigning any reason. In no event Management Trainee shall Claim permanent employment in the Company.

### 4. Compensation / Stipend

- a. Management Trainee shall be paid a fixed compensation of **INR.30,000/- (₹Thirty Five Thousand only)** and **INR.5000/-(₹Five Thousand only)** as expenses per month. Payment will be subject to income tax as applicable.
- b. The payment shall be made by the Company monthly either by an account payee cheque or transfer to the account of the Management Trainee. The payment will be made by 7<sup>th</sup> of every month.

### 5. TRAVELLING

- a. Any travel to locations outside base location would be arrange by the company as per the company Domestic Travel Expense Reimbursement Policy.
