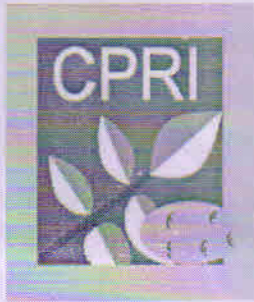

BETWEEN

Central Potato Research Station, Gwalior, M.P. a constituent Research Institute of Indian Council of Agricultural Research (ICAR), a society registered under the Registration of Societies Act (Act XXI of 1860), (herein after referred to as CPRS, Gwalior) of the one part.

AND

The ITM University Gwalior was set up by Act No. 12 B of vide extra ordinary Gazette notification of the Govt. of Madhya Pradesh dated 16/08/2011 And approved by the UGC under section 2 (f) of the UGC Act. The University commenced academic activities from..... of the other part.

WHEREAS Central Potato Research Station(CPRS), Gwalior, MP is India's premier Institute for potato research having scientific staff with specializations in Agronomy, Bio technology, Bio chemistry, Crop improvement, Plant protection, Plant Physiology and Post harvest Technology, Seed Production, Social Sciences, Computer Sciences, GIS and Remote Sensing etc. These scientists are well trained in their field in India and abroad. There are several prestigious International Collaborative projects on going at the CPRI.

WHEREAS ITM University Gwalior offering Agriculture Educational Courses such as B.Sc. (Ag) Hons, M.Sc. (Ag) in Agronomy , Horticulture and Genetics & Plant Breeding.

It is, therefore, proposed to extend collaborative efforts between Central Potato Research Station, Gwalior herein after referred to as CPRS, Gwalior, which has well equipped laboratories having most modern scientific instruments/ facilities and also excellent physical and technical facility for doing research on potato with that of the ITM University Gwalior, which is having adequate facilities in post graduate teaching and research.

For jointly undertaking post graduate education, research and training with the following terms and conditions applicable to CPRS, Gwalior (here in this case referred to as CPRS, Gwalior) and ITM University Gwalior.

Now this Memorandum of Understanding (MoU) witnesses that:

1. The ITM University Gwalior shall offer Ph.D degrees to JRFs/SRFs/RAs and other staff (regular or contractual) working at CPRS, Gwalior who are fulfilling the educational qualifications as per the rules and regulations of the ITM University Gwalior with respect to intake of students.
2. The University shall be responsible for realization of all fee and dues form the students enrolling for Ph.D and maintenance of all the records pertaining to the degree required.
3. CPRS, Gwalior shall offer students and staff (regular or contractual) from ITM University Gwalior to carry out research work at CPRS, Gwalior as per the mandate of CPRS, Gwalior and ICAR guidelines.
4. The students and staff (regular or contractual) from ITM University Gwalior as well as to JRFs/SRFs/RAs and other staff (regular or contractual) working at CPRS, Gwalior desire to undertake research work fully or partially at CPRS, Gwalior and course work at ITM University Gwalior will have to get the application recommended from faculty members of CPRS, Gwalior.
5. The MoU also envisages to JRFs/SRFs/RAs and other staff (regular or contractual) working at CPRS, Gwalior enrolled for Ph.D. with the ITM University Gwalior will be assigned major advisor from the CPRS, Gwalior and the Co-advisor from ITM University, Gwalior. Whereas, the students of the ITM University Gwalior desire to carry out research work as CPRS, Gwalior will be assigned Major advisor from ITMU Gwalior and the Co-advisor form CPRS, Gwalior.
6. The students desire to work at CPRS; Gwalior will have to select problem/area of research as per the mandate of CPRS. One of the scientists in concerned/ related discipline from CPRS, Gwalior will act as Major advisor or Co-advisor.
7. The students in consultation with Major advisor and Co-advisor can carry out his/her research work fully or partially at CPRS, Gwalior and ITM University Gwalior depending upon the facilities available.
8. The field and laboratory facilities will be shared by both organizations on mutually agreed term basis.

9. The collaborative programmes between two organizations shall be co-ordinate by a co ordination committee consisting of one member from each organization appointed by CPRS and ITM University Gwalior.
10. Data generated as a result of the collaborative work will be the joint property of both CPRS and ITM University Gwalior.
11. All publications emerging out of the collaborative work of the student shall be joint publication of CPRS and ITM University Gwalior with due credits to all then collaborators as per actual contribution made by the researchers of both the organizations.
12. In case the research is carried out solely by the organization or the research results are obtained through the sole and separate efforts of the organization, the organization concerned alone will apply for the grant of IPR and once granted, the IPR will be owned by the concerned organization.
13. In case research results obtained through joint activities, the IPRs granted through such joint activities during the tendency of the project under this MoU shall be property of both CPRS and ITM University Gwalior and it will be owned/shared between the two organizations/personnel as per the ICAR policy in vogue in IPRs.
14. The decision regarding the patenting of technology shall be taken jointly the coordination committee. In case the technology developed is to be patented, the cost of patenting and benefits shall be shared as per ICAR guidelines. Rights pertaining to third party if, any will be decided jointly by the first two parties. Rights of commercialization shall rest with both the organizations and shall be decided by the coordination committee.
15. Either of organizations hereto shall be entitled to terminate the MoU at any time with valid reasons acceptable in writing to both the organizations and in such case, the MoU will terminate six months after the date of written notification or date of expiry of the MoU, whichever is earlier. In case of such premature termination of MoU, all rights and obligations of both the organizations shall automatically cease except for those covered by written contract including ongoing collaborative research activity that can no longer be cancelled till it is completed.

16. In the event of any dispute that may crop up during execution of MoU, the matter would be settled through arbitration by referring to Arbitration Committee comprising of a member nominated by two organization and one member will be jointly nominated by two organizations.

17. This MoU shall be effective from the date signing and shall remain in force for a period of ten years from the said date and may be extended for further periods by signing fresh MoU.
