| 1. Degree Title | 5 years B.B.A. LL.B.(Hons) |
| 2. Duration of the Course | Minimum 5 years (10 Semesters),
Maximum 7 years (Semesters) |

Minimum Eligibility | <p>Candidates who have passed:</p> <ul style="list-style-type: none"> ❖ Final examination of the 10+2 system, conducted by any recognized Central/ State Board, such as Central Board of Secondary Education, New Delhi; Council for Indian School Certificate Examination, New Delhi, etc <li style="text-align: center;">OR ❖ Any Public School/Board/University examination in India or in any foreign country recognized as equivalent to 10+2. <li style="text-align: center;">OR ❖ Candidates who have obtained +2 Higher Secondary pass certificate or First Degree Certificate after Prosecuting studies in distance or through correspondence are eligible <li style="text-align: center;">OR ❖ Senior Secondary School Examination conducted by the National Open schooling with a minimum of five subjects. <p>Explanation: The applicant who have obtained 10+2 through open School system directly without having any basic qualification for prosecuting such studies are not eligible for admission in law course.</p> |
| 4. Admission Procedure | On merit basis of the qualifying examination / entrance examination following norms of the concerned regulatory body BCI and approved by Admission Board of University. |
| 5. Total Seats | Decided by Admission Board/ Academic Council of University as per norms of the BCI and subject to revision from time to time. |
| 6. Examination | Examination will be conducted as per the BCI Rules. The scheme of examinations, promotion to subsequent semesters and course of studies shall be as per the recommendations of the concerned Board of Studies with due approval of Academic Council. The medium of instructions and examinations shall be English throughout the course of studies. |

- 7. Course Structure** Course structure shall be as per the recommendation of the concerned Board of Studies of the school of the University duly approved by the Academic Council following the norms of BCI.
- 8. Eligibility for Degree** Eligibility for Award of the 5 years B.B.A. LL.B. (Hons) Degree if he/she has.
- a) registered and successfully completed all the core courses, moot court room exercises and projects up to ten semester.
 - b) successfully acquired the minimum required credits as specified in the curriculum corresponding to the branch of his/ her study within the stipulated time;
 - c) earned the specified credits in all the categories of subjects;
 - d) secured overall CGPA of 5.0
- 9. Attendance Requirement** A candidate must have at least 75% attendance. In case the attendance is less than 75%, special permission of Vice Chancellor shall be required.
- 10. General Instructions and Provision** For matters not covered in this specific ordinance general rules and regulations of University regarding specific courses are applicable.
- In other matters, Academic Council / Board of Management shall be competent to take any decision.
