| 1. <b>Degree Title</b>                         | M.Sc.   |
| 2. <b>Name of Faculty</b>                      | School of Science   |
| 3. <b>Duration of the Course</b>               | Full-time two years (four semesters)  |
| 4. <b>Minimum Eligibility</b>                  | <p>A candidate seeking admission to M.Sc. should be a Science Graduate with relevant subjects having obtained at least 50% marks in aggregate from any UGC/ AICTE approved Indian University or from a foreign University recognized by UGC or institute recognized by the ITM University as equivalent thereto.</p> <p>The Bachelor's degree must be of minimum three years duration after passing Higher Secondary (10+2) examination or equivalent.</p>  |
| 5. <b>Admission Procedure</b>                  | On merit, on the basis of the qualifying examination/entrance examination following norms of the concerned regulatory body and approved by Admission Board of ITM University.   |
| 6. <b>Total Seats</b>                          | Decided by Admission Board of ITM University as per norms of the concerned regulatory body and subject to revision from time to time.   |
| 7. <b>Examination</b>                          | Examinations will be conducted as per the appropriate statutes and ordinances in this respect. The scheme of examinations, promotion to subsequent semesters and course of studies shall be as per the recommendations of the concerned Board of Studies with due approval of Academic Council. For matters not covered in this ordinance, General rules and regulation shall be applicable. For all other matters, the decision of the Board of Management shall be binding.   |
| 8. <b>Eligibility for Degree</b>               | <p><b>Eligibility for Award of the M.Sc. Degree</b></p> <p>A student shall be declared to be eligible for award of the M.Sc. degree if he/she has:</p> <ol style="list-style-type: none"> <li>a) registered and successfully completed all the core courses and projects;</li> <li>b) successfully acquired the minimum required credits as specified in the regulations corresponding to the branch of his/ her study within the stipulated time;</li> <li>c) earned the specified credits in all the categories of subjects;</li> <li>d) secured a CGPA of 5.0.</li> <li>e) no dues to the University, Hostels, Libraries, NCC / NSS / NSO etc. and</li> <li>f) no disciplinary action is pending against him / her.</li> </ol> |
| 9. <b>Attendance Requirement</b>               | A candidate must have at least 75% attendance. On medical grounds it may be relaxed as admissible within applicable regulations.  |
| 10. <b>General Instructions and Provisions</b> | For matters not covered in this specific ordinance general rules and regulation of ITM University regarding specific courses are applicable. In other matters Board of Management of ITM University shall be competent to take any decision.  |
